# 1. Purpose of the Program

The Institutional Development Plan (IDP) serves as a strategic roadmap for higher education institutions (HEIs) to enhance institutional growth, improve academic performance, and ensure compliance with national education policies.

It provides a structured framework for institutions to assess their current status, set long-term goals, and implement systematic improvements in key areas such as curriculum development, faculty capacity building, research innovation, and student support services.

IDP plays a crucial role in accreditation processes, faculty development, student learning outcomes, governance efficiency, and overall institutional excellence. By integrating IDP into their strategic planning, institutions can strengthen their academic standards, enhance faculty and student engagement, improve research output, and align themselves with national frameworks such as NEP 2020, NAAC accreditation, and NIRF rankings

The primary objective of the National Level Awareness Program on IDP was to create awareness among HEIs about the significance of structured institutional planning, provide strategic guidance on formulating and executing IDPs, and equip institutions with the necessary tools and methodologies for effective implementation.

## 6. Detailed Report of the Event

The National Level Awareness Program on Institutional Development Plan (IDP) for Higher Educational Institutions (HEIs) was successfully conducted on Thursday, 6<sup>th</sup> March, 2025, in Online mode.

The event was jointly organized by the Telangana Council for Higher Education (TGCHE) and the Institute for Academic Excellence (IAE), Hyderabad. This program was aimed to provide a strategic roadmap for institutions to develop and implement their IDP, aligning with national and global educational standards. The event witnessed active participation from various higher education institutions, academic leaders, and industry experts. All in all 2627 participants from about 1000 Higher Education Institutes, from across the country were registered and participated.

#### **Event Highlights**:

The program featured insightful discussions, expert sessions, and interactive panels that provided institutions with a comprehensive understanding of IDP formulation and execution. The event was meticulously organized, ensuring seamless delivery of knowledge and best practices.

The inaugural session was graced by eminent dignitaries and include Dr. Nirmal Jeet Singh Kalsi IAS (Retd.), Former Chairman, NCVET, New Delhi, Chairman, UGC Committee for preparing IDP Guidelines as Chief Guest. Prof. Balakista Reddy, Chairman, TGCHE, Hyderabad, Prof. Dr. V. Ramgopal Rao, Vice Chancellor, BITS, Pilani as Guest of Honour, Prof. S. S. Mantha, Former Chairman, AICTE, New Delhi, Adjunct Professor, National Institute of Advanced Studies, Bengaluru as Keynote speaker.

Shri. K. Venkatesh Director, Institute for Academic Excellence, Hyderabad, had welcomed the dignitaries and set the tone for the program, giving an elaboration and an overview on the objectives and significance of IDP.

Prof. Dr. V. Balakista Reddy, Hon'ble Chairman, Telangana Council of Higher Education (TGCHE) has highlighted the global developments in shaping the higher education. He has emphasized on the need of the internationalization of higher education in the light of recent

world trade organization (WTO) and General Agreement on Tariffs and Trade (GATT) treaties on higher education. He has also urged the HEIs, to focus on formulating and implementing IDP in their institutions to position themselves at national level and project India as global knowledge hub.

Dr. Nirmal Jeet Singh Kalsi, in his chief guest address, had Stressed the importance of IDP as a blueprint for institutional growth. While discussing the significance of resource and capacity management in an HEI, he has emphasized on quality assurance, goal setting, and stakeholder involvement in IDP implementation.

Prof. V. Ramgopal Rao, guest of Honour, while launching the new web site <u>www.professors360.com</u>, specially designed by IAE for the benefit of the professors, emphasized the critical role of faculty in building the HEIs as Institutions of Excellence and Eminence. He had suggested for the designing of doctoral programs that foster startup incubation.

Prof. S. S. Mantha gave the key note address providing the insights on the national and global perspectives of IDP. He has also emphasized the significance of a structured Institutional Development Plan in achieving academic excellence, enhancing infrastructure, and improving student outcomes. He has highlighted the need to work on the skill gaps, explore various IDP Enablers to develop both short as well as long term goals and strategies keeping the developmental needs of an institution.

### **Technical Sessions**

# Session 1: Restructuring Higher Education Institutional Frameworks: Embracing Outcome-Based Education for a Future-Ready Workforce.

**Dr. Sandhya Chintala**, Executive Director, IT – ITeS Sector Skills Council & Vice President, NASSCOM, highlighted strategies to enhance institutional frameworks. She has also stressed on the out come based education and especially the curricular aspects, to be designed jointly by the university and industry looking into the need and requirements of innovation, research and development and entrepreneurship aspects. Therefore, she has suggested for a close university- industry collaboration for mutual benefits. She has offered and proposed online faculty development programs through NASSCOM future skill programs.

#### Session 2: Strategies and Best Practices for Developing IDP: Case Studies:

This session went parallelly discipline wise: University, Law & Agriculture, Engineering, Management, Medical, Dental & Pharmacy, Colleges. Different Experts from various disciplines shared their experiences in planning and implementation of IDP at their institutions. # Session 3: Role of IDP enablers in formulating a strategic road map to achieve the institutional goals.

This session was chaired by **Prof. N.V. Ramana Rao**, Director NIT- Raipur. The other panellists were Dr. Y.M. Jayaraj Vice-chancellor, Pravara Institute of Medical Sciences, Dr. Mangala Sunder. K, Emeritus professor, Dept. of Chemistry, IIT Madras, Prof. G. Simon Thattil, Dean faculty of Commerce university of Kerala, Prof. Bhaskar Bhattacharya, Banaras Hindu University, Prof. Ajay M. Sidpara, IIT Kharagpur. The discussion points centred around: Establishing governance structures for effective IDP execution, Aligning IDP with institutional rankings and accreditation frameworks and Enhancing research and development through strategic partnerships.

#### Session 4: Open Form: Impact of IDP on Institutional Rankings and Accreditation

In this session, following resource persons gave a brief on the topics mentioned against their names: Dr. B. Rushi Kumar, VIT Vellore – Correlation between IDP and NIRF rankings, Prof. B. Raja Shekhar, Former Pro Vice-Chancellor, University of Hyderabad – IDP strategies for NAAC accreditation, Shri K. Venkatesh, Director, IAE – Best practices for accreditation and quality assurance, Dr. Nandhibatla Viswanadha Sastry, Director, Ranking & Accreditation, IAE – Role of IDP in continuous institutional improvement. Following points were discussed: Strengthening curriculum design, faculty training, and student support systems, Implementing quality assurance mechanisms for IDP success, Developing partnerships with industries for practical learning and career development.

Some of the suggestions from participants are listed below.


- The duration of the sessions and the number of days of the workshop should be increased.




