The firms must have the experience of executing similar work with at least three (3) years of experience in admissions of Telangana State with a minimum of 25000 candidates. The firm must be located in the GHMC area of the State of Telangana. The last date for submission of quotations in sealed covers separately for Technical bid and Commercial bid along with other enclosures to the undersigned is 09-06-2025 by 5:00 P.M.

The sealed quotations will be received up to Dt.09-06-2025 till 5.00 P.M and will be opened on Dt: 10-06-2025 at 11:00 A.M.

The following is the scope of work to be executed:

Application- Online Certificate Verification

- Online registration and uploading of certificates
- Collection of Online Registration Fee
- Online Verification of Certificates
- Application maintenance and support
- Data Validation and generation of Reports

Web Options - Application Development and Hosting

- Providing Online application to accept web options from qualified students
- Application and Database maintenance
- Hosting & Technical support

Providing Web Based Allotment Process

- Web options data scrutiny
- Allotment process as per the rule of reservations of Telangana State rules and regulations
- Hosting of qualified candidate's data and maintenance
- Providing required technical support for exercising web based options by all qualified candidates
- Sending required information to candidates through SMS and mails
- Collection of Course Fee.
- Hosting of allotment lists, candidate wise and college wise
- Data Base Back-up & Maintenance
- Generating required reports as and when necessary
- Any other incidental tasks necessary for completing the admission process
- Database should be transferred in a soft copy to the Convener, TG CETs (other) Admissions – 2025.
- The successful bidder has to offer the services from the date of commencement to the end of the admissions process of TG CETs (other) Admissions – 2025 which shall be for 4 months.

Note:

- 1. Price should be per each candidate who exercised the web options.**
- 2. First the Technical Committee will open the Technical bid and if all the Technical conditions are satisfied then only the Commercial bid will be opened and considered.**
- 3. The technical bids will be opened only if minimum two firms submit the bids. The Convener shall renotify/readvertise the tender if only one tender is submitted**
- 4. All disputes if any shall fall within the jurisdiction of Hyderabad only.**
