INSTRUCTIONS

(GUIDELINES FOR CONDUCTING CATEGORY-B ADMISSIONS UNDER MANAGEMENT QUOTA (20% SEATS) IN PRIVATE UNAIDED NON-MINORITY/MINORITY LAW COLLEGES IN THE STATE OF TELANGANA FOR THE ACADEMIC YEAR 2026-27)

The Managements of Non-Minority / Minority Private Unaided Law Colleges are required to follow the admission guidelines issued as below for conducting process of Management Quota (Category 'B' admissions) in a fair, transparent and non-exploitative manner by the managements of the colleges to fill up 20% management seats in 3 Years LL.B, LL.B (Hons) / 5 Years B.A.LL.B, B.A.LL.B (Hons), BBA.LL.B, B.Com LL.B for the academic year 2026-27.

1. IMPORTANT NOTE:

All the Admissions shall be made in accordance with the provisions of the relevant G.O.s viz., G.O.Ms. No.64, Dt: 26.05.2006, G.O. Ms. No. 250, Dt: 27.10.2008, G.O. Ms. No. 31 &32, Dt: 18.03.2009, G.O. Ms. No. 116, Dt: 07.08.2007 as the case may be and their subsequent amendments. (Adaptation of Test & Admissions rules by the Govt. of Telangana vide G.O.Ms.No. 33, (HE(TE/A2) Dept., Dt: 31.12.2014)

2. ESSENTIAL ELIGIBILITY CONDITIONS [for 3 Yr/ 5 Yr LL.B Courses]

- Candidate should be an Indian National.
- Rank Card in TG LAW CET - 2026.
- Educational Qualifications:

(i)	Any degree from a recognised University in India in 10+2+3 for 3 yr LL.B/B.L Degree and 10+2 pattern for 5 year LL.B./B.L Degree.
(ii)	Candidate should secure the following percentage of marks in the Qualifying Examination. 45% for OC / BC 40% for SC / ST
(iii)	Candidates who have less than prescribed percentage of marks but have secured the same percentage or more on the aggregate in any PG Degree (Master Degree) or B.Ed. are also eligible for admission into 3 Years LL.B Course.
(iv)	Candidates who have passed Degree examination by single sitting without undergoing three years course either through regular or private or correspondence and those who obtained the Degree through Open University system directly without having any basic qualification are not eligible.
(v)	Candidates who have obtained 10+2 or graduation / post graduation through Open University System directly without having any basic qualification are not eligible.

- Vacant seats if any may be filled with eligible candidates on merit basis who have passed the qualifying examination and it shall be ensured that all the eligible rank holders are considered for admission, before filling up vacant seats.

3. ***Approval of the candidates Graduated through Distance mode from other State Universities as per the guidelines issued by the University Grants Commission, New Delhi vide (F.No. 2-4/2015(DEB-III) Dt. 23.06.2017***

The college managements are informed to verify results and genuineness of the pass certificates submitted by the candidates and also responsible for the admission made under Category 'B' Management Quota (20%) seats for all purposes. The managements shall comply with the above and failure in implementing the same shall entail actions as per the relevant Acts and Rules in force.

1. The Management shall UPLOAD the details of students admitted under Category-B Management Quota through online by logging onto <https://catb.tgche.ac.in>. The detailed user manual / steps for uploading the details of admitted students and payment gateway system is available in the above portal.
2. Submit the Hard copy of the uploaded list of students admitted under Category-B Management Quota with signature and seal of the Principal of the College. **(Annexure-I, II & III)**.
3. Pay the processing fee of **Rs.800/-** for each candidate through payment gateway system available in the <https://catb.tgche.ac.in>.

The closing date for the admissions shall be same as prescribed for spot admissions by the convener (Admissions) TGLAWCET 2026 for filling up vacant seats under Cat-A by the managements

*The last date for submission of the admission lists (Category 'B' seats) to the Competent Authority (TGCHC) is **07.09.2026***

It is also informed that late submission of proposals beyond the cut-off date mentioned above will not be permitted under any circumstances, and the College Management will be held responsible for the ratification of the students admissions.

The managements are directed to submit the proposals separately for each course along with the relevant certificates / documents in the following order in **HARD COPY** indicating LAW CET CODE & Course viz., 3 Years LL.B / 3 Years LL.B (Hons) / 5 Years B.A. LL.B / 5 Years BBA. LL.B / 5 Years B.Com LL.B. along with the following documents.

1. Copy of Affiliation order from concerned University.
2. Copy of approval by the BCI.
3. Original paper notification for filling up of 20% management quota seats
4. Copy of the applicant list who were applied both online and in person for each course for 20% management quota who were applied both online and in person for each course for 20% management quota (a) CET wise rank List and (b) Marks in the qualifying examination
5. Copy of merit list of the candidates who were applied both online and in person for each course for 20% management quota

6. Abstract of Admissions made in the college under Category 'A' & 'B' seats.
 7. Annexure - I (Details of Admissions made under M.Q (20%) seats for the A.Y. 2026-27 (separate proforma of Annexure-I for admissions made into each course shall be furnished)
 8. Undertaking on the letter head by the Principal/Secretary/Correspondent of the institution on Rs.100 Bond paper.
 9. Signature of the Principal/Secretary/Correspondent of the institution with seal must be available on all the copies submitting to the Competent Authority, TGCHE for grant of approval.
4. All the colleges are further directed to submit the admission list along with the following information in respect of each student with documentary evidence:
- (i) TG LAW CET-2026 Rank Card,
 - (ii) The list of candidates admitted shall be submitted by the College along soft copy in Annexure-I in the proforma prescribed,
 - (iii) Undertaking enclosed (Annexure-II) in the given format on Rs.100/- stamp paper should be submitted by the Secretary / Correspondent of the College
5. **ALL ORIGINAL CERTIFICATES ARE TO BE SUBMITTED AT THE TIME OF THE VERIFICATION**
6. *The Managements are not required to submit the Xerox copies of student certificates, however the copies of certificates to be submitted to the office whenever required.*
7. Lists submitted after the cutoff date shall not be accepted.
