INSTRUCTIONS

GUIDELINES FOR ADMISSION INTO B.PEd and U.G.D.P.Ed COURSES UNDER CATEGORY ' B' (BASED ON G.O.MS.NO. 14 dt: 21.01.2008 and G.O. MS.No. 43, dt: 17.03.2008)

ELIGIBILITY CRITERIA

1. Candidate must be an Indian National.
2. Rank Card in TGPECET - 2026.
3. Educational qualification / Eligibility criteria
 - i) Any degree from a recognised university in India in 10+2+3 for B.P.Ed and 2 year Intermediate course or Intermediate Vocational course in any field conducted by the Board of Intermediate Education, Telangana or any other examination recognised as equivalent to above examinations for U.G.D.P.Ed course
 - ii) Candidate should secure the following percentage of marks in the Qualifying Examination.

40%	-	OC
35%	-	SC/ST/BC
 - iii) Vacant seats, if any, may be filled with eligible candidates including those securing not less than 40% marks in aggregate in the qualifying examination duly ensuring merit and transparency
4. The Managements of the Colleges are instructed to conduct Physical test to all the candidates applied by appointing Physical Director of nearest Government Colleges.
5. There is no upper age limit for admissions into B.P.Ed / U.G.D.P.Ed courses, However, the candidate should have completed 19 years for B.P.Ed and 16 years for U.G.D.P.Ed
6. The Management shall **UPLOAD** the details of students admitted under Category-B Management Quota through online by logging onto <https://catb.tgche.ac.in> The detailed user manual / steps for uploading the details of admitted students and payment gateway system is available in the above portal.

7. Submit the Hard copy of the uploaded list of students admitted under Category-B Management Quota with signature and seal of the Principal of the College. (Annexure-I & II).
8. Pay the processing fee of **Rs.500/-** for each candidate through payment gateway system available in the <https://catb.tgche.ac.in>
9. All the colleges are further directed to submit the admission list along with the following information in respect of each student with documentary evidence:
 - (i) *Rank Card in TGPECET-2026*
 - (ii) *The list of candidates admitted shall be submitted by the College along soft copy in Annexure-I(MS-Excel format only), in the proforma prescribed, (Proforma can be downloaded from the website www.tgche.ac.in*
 - (iii) *Undertaking enclosed (Annexure-II) in the given format on Rs.100/- stamp paper should be submitted by the Secretary / Correspondent of the College.*
 - (iv) Report of Physical test given by Physical Director.

10. ALL ORIGINAL CERTIFICATES ARE TO BE SUBMITTED AT THE TIME OF THE VERIFICATION

11. *The Managements are not required to submit the Xerox copies of student certificates, however the copies of certificates to be submitted to the office whenever required.*
